Dear Congressman Johnson,

Thank you for the opportunity to submit projects for consideration for the FY 2022 Community Project Funding. Submitted for your consideration: Elkton Wastewater Treatment Plant Upgrades Project and the Lacroft SR 267 Sewer Main Project.

As you know the Columbiana County Sanitary Engineer, Bert Dawson, P.E is charged with the responsibility of the operation and maintenance of all the County's Wastewater Treatment Plants and sewer lines throughout the County. Maintenance, repairs and operational costs for these facilities continue to rise each year and it is imperative that they function properly or the effect would be catastrophic on the communities they serve and the environment would be negatively impacted.

The Elkton Wastewater Treatment Plant is a Class III facility located in Elkrun Township outside of Lisbon Village and is the largest plant in the County. The plant is over 25 years old and serves the Elkton Federal Prison, Lisbon Village, the Columbiana County Career and Technical Center, a hotel, restaurants, and other various commercial properties. This plant also processes almost two million gallons annually of additional sewage from septic haulers, which can drastically impact the treatment processing at this plant.

The funding that is being requested for this plant will replace the old pumps that are used daily, and the equalization chamber will serve as a holding station for the additional sewage received from the septic haulers, so it can be slowly introduced for processing and not cause chemical treatment issues.

The second funding request is for the first phase of construction for a Sewer Main in the Lacroft SR 267 area of Liverpool Township. This area has a longstanding sewage issue and is under Orders by the OEPA. The construction cost for this project would have a huge, negative financial impact on this low-income community. We have found that when a community is burdened with a monthly sewage bill, that includes a large, long-term loan charge, it inevitably results in negative monthly revenue, and repairs, maintenance and processing costs become ongoing financial issues for the County. This funding could help reduce these issues and resolve the environmental nuisances in this area, which will produce a better quality of life for its residents.

Hopefully, we have provided you with a better understanding of these projects and positive impact they will have on the communities they serve. Therefore, the Columbiana County Board of Commissioners hereby wholeheartedly support these necessary projects.
