

## Hauling Permits with Road Bonds

The following options will allow for hauling equipment and/or materials to or from your site year round using trucks with legal Ohio axel loads.

- 1.) A *Company Check* can be sent to our office in the amount of \$10,000.00 per mile traveled on the road. The check will be deposited into a county account. This account will be established as a separate account strictly for your project. If repairs are made and the account balance falls below \$5,000.00 we will send your company an invoice showing how the funds were spent and request additional funding to bring the account balance back to the \$10,000.00 per mile limit. At the completion of your project, we will return any unused funds to your company.
- 2.) An *Irrevocable Letter of Credit* can be established at a bank of your choice. The letter shall be drawn in favor of the Columbiana County Commissioners in the amount of \$10,000.00 per mile traveled. The letter shall have a provision that the bank will pay the Commissioners the requested amount upon receipt of a letter requesting payment. The Commissioners shall only make this request if you fail to make payment as outlined in the next paragraph. The Letter shall be effective until the completion of your project and shall only be terminated by the written consent of the Commissioners. The letter of Credit shall be subject to the Uniform Customs and Practices for Documentary Credit (latest addition), International Chamber of Commerce Publication Number 500.

If road repairs are made, your company will be sent an invoice for the amount of funding spent to make the repairs. You will have thirty days to repay the County for the repairs. If payment is made within thirty days then the Letter of Credit shall remain in force; however, if payment is not received after the thirty day limit then the County will request payment from the bank and your hauling permit will be suspended.

If your route is less than one mile in length the road bond amount shall be \$10,000.00 but may be reduced by the county depending on the actual length traveled.

If repairs are needed the County shall provide the labor and materials for the work. An invoice will be sent to your company outlining the repairs made and the amount of funding used. The invoice form used will be the Auditor of State's Force Account form.

If your road is posted with a frost law weight reduction from November through April either of the above options will allow your company to continue hauling at legal weight limits throughout the year; however, the County hereby reserves the right to suspend hauling during days of extreme thaw if the road is showing excess damage due to the thaw.

This permit does not give you the right to haul over weight or over width vehicles on the road. A separate special hauling permit shall be obtained from the County for overweight and/or over width loads.
