Marking: A stake or flag shall be placed in the work area, so the county highway

supervisor can locate the area.

After the application and plan are complete and returned to the county engineer's office, a county highway supervisor will inspect the work area. The supervisor will determine if the project will conform to the construction standards established by the county engineer.

No Open Cutting Of Any County Roadway Shall Be Permitted.

Columbiana County Specifications And Requirements

Construction Notification

The Owner or authorized contractor shall give notice to the County Highway Superintendent at least 48 hours prior to the start of construction. (330) 424-3519.

Preconstruction Meeting

The Owner and Contractor may be required to meet with the County Highway Superintendent prior to starting construction. The contractor shall have a detailed construction schedule, material list, supplier list, construction sign plan, detour plans and any other pertinent information.

Construction Specifications

All materials used in the reconstruction of a County Road Right of Way shall meet or exceed the ODOT Construction and Materials Specifications, latest edition.

Traffic shall be maintained at all times in accordance with the current Ohio Manual of Uniform Traffic Control Devices. All signs and their placement shall be approved by the County Highway Superintendent prior to the start of construction. One lane traffic must be maintained throughout working hours with flaggers using Stop/Slow paddles and two-way radio communication. Both lanes shall be opened to traffic after work hours and on weekends with proper warning lights installed for night. If the road cannot be opened to two lane traffic a suitable detour shall be established by the contractor with directional signage and proper barricades closing the work area. Notification shall be given to the local newspapers at least 48 hours prior to installing a detour.

All phases of the work shall be inspected by the County Highway Superintendent and his approval must be given before additional work can continue.

The utility owner and contractor shall give the County Highway Superintendent phone numbers so that they may be reached 24 hours a day, and they shall have someone available 24 hours a day if needed.

Utility Location And Depth Shall Meet The Attached Minimum Requirements Drawings.

Open Cutting Shall Not Be Permitted On County Roads.




MINIMUM REQUIREMENTS FOR UTILITY CONSTRUCTION WITHIN A COUNTY ROAD RIGHT OF WAY
